We are grateful for the opportunity to support you and your family with anonymous counseling services at a discounted rate. This program is open to pastors, teachers, SECC office employees, as well as their spouses and immediate family members.

How the Program Works

- Eligible individuals receive this document, which includes program details and a list of participating counselors.
- Contact any counselor from the list and let them know you are part of the SECC Anonymous Counseling Program.
- The counselor will confirm your eligibility with Human Resources (HR).
- HR will not keep permanent records of the counseling services provided and will not disclose the names of those receiving counseling. Confidentiality is strictly maintained in line with HIPAA requirements.
- You will provide the counselor with a \$20 copay for each session.

About Our Counselors

All counselors on our list meet the following criteria:

- They have chosen to participate in this program and are able to support individuals in the Seventh-day Adventist Church context.
- They hold a valid license to practice in California, which HR verifies annually.

We recognize that not every counselor will be the perfect fit for every person. You are encouraged to speak with more than one counselor to learn about their background and approach so you can find the best match for your needs.

Important Notes

This is not an insurance program. Only the counselors on the provided list offer services at the discounted rate.

Counseling services may also be available through Kaiser and Ascend to Wholeness medical plans. These services are separate from this SECC Anonymous Counseling Program.
